Chapter 103E Drainage Authorities

Re: Ditch Buffer Strip Annual Reporting for Calendar Year 2019

Dear Points of Contact for County and Watershed District Drainage Authorities,

State drainage law (Minnesota Statutes, Chapter 103E) requires the establishment and enforcement of buffer strips of perennial vegetation along Chapter 103E drainage ditches when viewers are appointed for the following types of proceedings:

Type of Proceeding

- a. Ditch Establishment via 103E.212
- b. Ditch Improvement via 103E.215
- c. Improvement of an Outlet via 103E.221
- d. Laterals via 103.225, Subd. 2 and Subd. 3
- e. Redetermination of Benefits via 103E.351
- f. Repair by Petition via 103E.715, Subd. 6
- g. Including property not previously assessed benefits via 103E.741

In 2007, the Minnesota Legislature added Section 103E.067 Ditch Buffer Strip Annual Reporting, which requires drainage authorities to submit a report to the Board of Water and Soil Resources (BWSR) on a calendar year basis providing required information about public drainage ditch buffer strip establishment, inspection and enforcement. In accordance with this statutory requirement, and on behalf of BWSR, I am requesting your Ditch Buffer Strip Report for Calendar Year 2019. As in previous years, we are providing the reporting form. It is attached in the transmitting email and is on the BWSR website at http://www.bwsr.state.mn.us/drainage/ditch_buffer_strip_study.html.

Instructions:

- 1) When reporting on a Joint County drainage system, the county drainage authority that maintains the records is the only one that should submit the buffer strip reporting information for that drainage system.
- 2) If you are reporting on your county ditches and joint county ditch(es), please combine the reports.
- 3) Please double check all entries against actual ditch system activity records during the calendar year. Errors in data entry will make the statewide summary that BWSR must develop also in error. With nearly 100 drainage authorities reporting, review and validation of data entries is very challenging, including follow-up with drainage authority points of contact.
- 4) Even if you have no ditch buffer strip establishment or enforcement actions to report for the calendar year, please complete and submit the form as an Excel document by February 28, 2020 to Anna Gillette, Office and Administrative Specialist, at <u>anna.gillette@state.mn.us</u>, so that BWSR knows your drainage authority reported. As part of the required BWSR annual review of local government performance, BWSR reports compliance with this reporting requirement on our website and via the

annual Performance Review and Assistance Program (PRAP) report to the Legislature (e.g. LGU reported on time, late, or no response). Drainage authority reporting is also a component of the eligibility criteria for Clean Water Fund Competitive Grants.

For those who are new to this ditch buffer strip reporting, be aware that multiple reminders are sent out by BWSR prior to the reporting date, until a report is received. If no report has been submitted by the week prior to the reporting date, BWSR will check to see that the email addresses it uses are correct. Any corrections of email addresses that you can help provide are appreciated. The last drainage authorities to submit their report may be contacted via phone to assure correct email addresses and receipt of the original report request and subsequent reminders.
