CREP Agreement Signed

Last month, Governor Mark Dayton signed a \$500 million Conservation Reserve Enhancement Program (CREP) Agreement with the United States Department of Agriculture (USDA). Refer to the Minnesota CREP webpage for more information, as it is released.

We've Moved: How to Reach BWSR Easement Staff

Placing the easement number in the Subject Line of the email enables us to process these emails more quickly.

RIM Reimbursement Process Change

BWSR will be executing a Master Joint Powers Agreement (MJPA) with each SWCD to enable SWCD payments for easement acquisition (\$2000/easement) and easement delivery (\$50/easement. We held two webinars in January, and a link to a recording of the January 23rd webinar is available on the Master Joint Powers Agreement (MJPA) webpage. A Question & Answer document will be posted to this webpage in the coming weeks.

BWSR Easement Maps & GIS Data

easement boundaries, GIS shapefile, and full metadata record. It was updated in early September and will continue to be updated on a quarterly basis.

Also remember that the RIM Handbook has been revised and is an extremely helpful guide to aide you in the processing of easements.

RIM Easement Ownership Changes

When an SWCD learns that easement land has changed ownership it is important to keep District and State records up to date and to inform the new landowner about the terms and conditions of the easement. Whenever possible, the SWCD should meet with each new landowner in person to review the easement and conservation plan practices in place on their property. For all ownership changes, the SWCD should provide the following to BWSR:

- The easement ownership change form, filled out completely with the new landowner's contact information:
- A copy of the recorded deed(s) conveying the land from the original grantor to the current owner. If
 ownership has changed multiple times, <u>BWSR</u> needs a copy of <u>ALL</u> recorded deeds to track the complete
 chain of ownership;
- A letter from the original grantor authorizing BWSR to make any remaining practice payments to the new landowner (if applicable).

The SWCD should also provide a copy of the recorded easement and the conservation plan and map to the new landowner for their records.

At this time, it is also important for the SWCD to verify that the easement boundary is properly posted to ensure the new landowner is aware of the location of the easement boundary.
