Draft Minnesota Nutrient Reduction Strategy

 As a follow up to the presentation in September by Dave Wall, MPCA, about the Nitrogen in Minnesota Surface Waters Report, Wayne Anderson, MPCA, provided an overview of the Draft MN Nutrient Reduction Strategy.

- The driving forces for the strategy are hypoxia in the Gulf of Mexico, eutrophication in Lake Winnipeg, protection of Lake Superior, eutrophication in MN lakes and rivers, and water quality standards for nitrogen in MN surface waters directed by the MN Legislature and anticipated to be rolled out in 2015.
- There was much discussion about the sources of nitrogen and phosphorus in MN, trends and proposed reduction strategies.

Section 103E.015 Considerations before drainage work is done

- The DWG 103E.015 Subgroup provided draft recommendations for updating of Section 103E.015 to the full DWG, with goals to update and clarify environmental, land use and water management criteria in drainage law, and to help make connection to 103E.011, Subd. 5 Use of External Sources of Funding (for wetland restoration, water quality or flood control) and other alternative measures (i.e. promote integration of public and private funding for multipurpose water management). Connection with the objectives for 1 Watershed 1 Plan (1W 1P) were again mentioned. It was noted that DWG members have had varying exposure to 1W 1P to date.
- Discussion was robust about recommended revisions and key words, indicating a need for
 refinement of draft revision language, more information about the existing pertinent provisions
 and operative words in drainage law and the Minnesota Public Drainage Manual, and further
 DWG discussion.
- Key concerns were in regard to how best to better enable multipurpose water management, time and costs for drainage project planning and implementation, and best use of existing structure and provisions of drainage law.

Drainage System Assessments to Road Authorities Subgroup Update

- MnDOT and BWSR staff met in Nov. to discuss 103D.729 Water Management District, and associated watershed district authority for drainage system assessments to benefited lands.
- MnDOT, Rice Creek Watershed District and BWSR staff met on Dec. 13, 2013 to discuss the runoff-based method and associated parameters used for recent water management districts in the RCWD.
