All in attendance introduced themselves, including those who participated via conference call. Al K. provided extra copies and an overview of the agenda. It was requested to add discussion about the state AgBMP Loan Program as a source of financing for Chapter 103E ditch buffer strips.

Acceleration of drainage system acquisition of ditch buffer strips and alternative practices

Don Buckhout, Project Manager, provided an overview of the status of the report to the legislature dated Feb. 1, 2018 (Handout 3)). The report was accepted by the BWSR Board at its meeting on Jan. 24, 2018 and will be sent to the required House and Senate committees by Feb. 1, 2018. Al and the DWG thanked Don for leading development of the report to help make it valuable and get it done before the

deadline. Al indicated that the associated DWG Legislation Subgroup met on Jan. 25, 2018 to discuss the draft legislation for Recommendations S1, S2, S3, S6, F1 and O1. Subgroup discussions are reflected in Handout 4), dated 1-26-18. DWG discussions about the draft legislation resulted in the following:

S1: Draft session law clarifying authority for drainage authorities to plant and maintain ditch buffer strips, with landowner consent, prior to Chapter 103E proceedings to acquire and compensate. It was noted that the sunset date for this provision was set as June 30, 2019 to be compatible with BWSR guidance regarding a planting deadline for native vegetation for best success. – All OK.

S2: Drafted to strengthen drainage authority jurisdiction for use of Section 103E.021, Subd. 6 in light of the Zimmerman case appeals court decision. – All OK.

S3: Revisions of Section 103E.351 to enable 26% or more of benefited landowners to petition for a redetermination of benefits, to update outdated language about original benefits and to make hearing provisions consistent with related provisions of Chapter 103E. – All OK.

S6: Revision of Section 103E.071 to clarify authorization for county drainage authorities to use outside legal counsel. – All OK

F1: Discussed potential need and source of additional Buffer Cost-Share. BWSR is evaluating reporting from SWCDs. Recommendation S1 legislation could increase need for Buffer C-S, but difficult to estimate. Fiscal year 2019 should be 2018. An effective date should be added, like S1. – OK as amended.

O1: MAWD and AMC reps have requested including update of the "Understanding Minnesota Public Drainage Law" document in information and outreach, which is needed sooner than later, due to the Nov. 1, 2018 Buffer Law deadline for public drainage ditches. BWSR will try to lead this update internally. Chapters 2 and 4 of the updated Minnesota Public Drainage Manual are key references. A project plan and project team will be needed, involving BWSR, AMC, MAWD, MASWCD and others.

P4: The DWG recommended adding this recommendation to draft legislation. This is about eligibility policies and increased loan funding for drainage ditch buffer strip financing. Dwight Wilcox, MDA AgBMP Loan Program Mgr., provided pertinent program information, as well as MDA discussions about potential legislation to streamline drainage authorities serving as a borrower on behalf of landowners for ditch buffer strip land rights acquisition and establishment. – This will need further discussion.

Runoff and Sediment Delivery Option for drainage system repairs

Al K. distributed the most current version of draft Chapter 103E revisions dated 1-31-18. All of the changes in and since the 1-7-18 version are shown in green text, with Al's changes in italics.

Changes in Sections 103E.005, 103E.095, 103E.615 and 103E.728, Subd. 1, Subd. 1a (a) and Subd. 1a (d) were all OK.

In Sec. 103E.728, Subd. 1a, para. (b), it was agreed to replace "field on-the-ground verification" with "appropriate on-site verification".

In Sec. 103E.728, Subd. 1a, para. (h), it was agreed to eliminate Alternative 1 and use Alternative 2 language, with the elimination of the phrase "if the report reasonably reflects current land use, relative runoff and relative sediment delivery" in the first sentence, and it was agreed to replace the word "order" with "approval" in the fourth sentence.

For Sec. 103E.728, Subd. 1a, para. (i), concern was expressed that Alternative 1, which was drafted to reflect DWG subgroup discussions, does not provide adequate flexibility for drainage authorities to adequately consider various site and runoff conditions for property with permanent conservation restrictions; and concern was expressed that Alternative 2 provides too much discretion to drainage authorities. Meeting time ran out for further discussion of para. (i).
