Introductions and agenda overview

All in attendance introduced themselves, including those who participated via conference call. Al K. provided extra copies and an overview of the agenda.

Approval of 2-1-18 meeting notes

Extra copies of the notes were distributed. Corrections or additions were invited. None were identified.

Acceleration of Drainage System Acquisition of Buffer Strips (ADSABS)

Members of the DWG Legislation Subgroup met on Tuesday, 2-20-18. Al K. provided an overview of recent changes reflected in the DWG ADSABS recommendations document dated 2-21-18. These changes only involve addition in Recommendation O1 of reference to the Understanding Minnesota Public Drainage Law (UMPDL) document. The UMPDL would need to be updated prior to providing outreach about accelerating drainage system acquisition of buffer strips, along with an overview of Chapter 103E drainage law. This request by AMC and MAWD was supported by other DWG members. Because potential request of funding for outreach wouldn't be available until FY-19, BWSR has agreed to work on the update of the UMPDL in the coming months.

At the 2-1-18 DWG meeting, the DWG had endorsed recommended legislation for Recommendation S1, S2, S3 and S6 and recommended adding Recommendation P4 about the AgBMP Loan Program use for

ditch buffer strips to draft legislation. Staff at MDA have been working on language to revise Section 17.117 Agriculture Best Management Practices Loan Program to enable drainage authorities to serve as a borrower on behalf of the landowners represented in a drainage system to help finance ditch buffer strips (up to number of landowners represented times the current limit of \$200,000 per landowner). MDA will continue to work on this legislation. MDA indicates that the program has been appropriated a total of about \$75M to date, with an outstanding loan balance of \$47M and \$28M of cash on hand, as of 2-1-18. The current annual sustainable loan capacity is about \$11M per year for all categories of loans, with varying use and funding availability of the five appropriation sources. Runoff and Sediment Delivery Option (RSDO) for drainage system repairs

Al K. distributed extra copies of the most current version of draft Chapter 103E revisions dated 2-19-18. All of the changes discussed and agreed to at the 2-1-18 DWG meeting regarding language in "green" font at that time have been incorporated into the "red" recommended revisions, in accordance with the notes for the 2-1-18 DWG meeting. Al provided an overview of those agreed-to changes.

The only remaining topic was Sec. 103E.728, Subd. 1a, para. (i) regarding conservation lands. Two alternative versions are shown in the 2-19-18 RSDO Chapter 103E revisions document. After some scheduling challenges, Al K. met with DNR and MCEA representatives on Wednesday, 2-21-18 to further discuss conservation lands. At that meeting, concern was raised that property owners should not be assessed / charged for runoff / drainage that is "natural", based on the "Seidlitz" case law and "reasonable use" doctrine considerations.

There was much discussion about the applicability, or not, of the Seidlitz case and reasonable use doctrine to drainage system repair cost apportionment using a proposed new RSDO authority in drainage law that is much like the separate authorities provided to cities, counties, watershed districts, and other water management organizations for stormwater management cost assessment for actual, existing drainage. Also discussion about existing Section 103E.315, Subd. 6 and 7 authority regarding viewers assigning benefits to accelerated drainage and sedimentation above "natural". The feasibility of being able to subtract out "natural drainage" and sediment from total drainage and sediment delivery in the RSDO prototype method was also discussed, including "presettlement" land use data such as the "Trygg maps". Concern was expressed about the need for drainage authorities to consider site specific situations, as well as the practicality and defensibility of defining "natural" drainage and sediment delivery. Because there was not consensus about how to address natural drainage and conservation lands, and the full DWG would not meet again before the start of the 2018 legislative session, Al K. requested one more meeting of an RSDO Subgroup for this last remaining issue, which was supported.

Short discussion about the introduction of the draft language that the DWG had reviewed in October 2017, with support for Al K. to send another letter to Rep. Backer and others involved about the DWG conclusions and reasoning.

Public Waters and Drainage Guidance

The DNR reportedly has completed a final version of their guidance document, which is being completed internally, along with planning for associated distribution and training within DNR.
