## **DWG Prioritized Discussion Topics List**

The revised list dated 7-13-18 is based on discussions at the 7-12-18 DWG meeting. The list eliminates completed topics, revises priorities for a number of topics, and includes the addition of a discussion topic to develop a DWG charter and an information topic to evaluate DNR concerns about reestablishing drainage system records (Sec. 103E.101, Subd. 4a). The 7-13-18 DWG Prioritized Discussion Topics List was adopted to guide priorities for the remainder of the year, or until it is next updated.

## DNR Concerns about reestablishment of drainage system records

Jim Sehl, DNR, provided an overview of a DNR summary of some recent reestablishment of drainage records that involve public waters and have resulted in disagreement between drainage authorities and DNR. Two situations were highlighted: Chippewa-Swift JD-9 and Lac Qui Parle CD-24. In both cases, DNR disagrees with the interpretation of borings used to define the as-constructed or subsequently improved condition for ditch bottom profile elevations. DNR has appealed the JD-9 reestablishment of records to the MN Supreme Court. For a repair that could affect public waters (Sec. 103E.701, Subd. 2), the drainage engineer, an SWCD technician and a DNR representative, must jointly determine the repair depth, but the drainage authority decides. Al will coordinate with the drainage system engineer and DNR to bring specific information about one or more of the above situations to future DWG meeting(s).

## **Accelerating Drainage System Acquisition of Buffer Strips recommendations**

Based on DWG discussions on 7-12-18 and to further clarify recommendation purposes, Al Kean had updated the 2018-2019 document (Final 8-3-18, Handout 5)). The recommended revisions of Section 17.117 AgBMP Loan Program were deleted, with commitment from MDA on 7-12-18 to include revisions for the 2019 legislative session to enable Chapter 103E drainage authorities to serve as borrowers on behalf of the property owners they represent (DWG Recommendation P4). Remaining Allen Wold concerns about revisions of Sec. 103E.351 were discussed, including the explanation of purpose in Handout 5) and DWG Rationale regarding Concern 1) in Handout 7), but full consensus was not reached.

#### Brief history of DWG discussion and development of the RSDO recommendations

Al Kean provided an overview of the summary documentation of the DWG initiation, investigation and development of the Runoff and Sediment Delivery Option for repair cost apportionment (Handout 6)). Al plans to use this as background information for an invited discussion at the Minnesota Viewers Association meeting on Aug. 16 about RSDO including Chuck Fritz, IWI and Zach Herrmann, HEI. Based on discussion for step 10) in the handout, it was recommended to not use "99%". Al will revise.

Information regarding Allen Wold, BdSWD, concerns about ADSABS and RSDO recommendations Information in Handout 7) that had not yet been discussed was overviewed by Al Kean and discussed, along with an overview of the information in Handout 8) regarding RSDO and constitutional concerns. No changes of positions or perspectives were identified.

## **DWG Charter / Member Guidance**

Based on discussions at the 7-12-18 meeting, and to find a way forward for DWG recommendations, a revised draft charter was developed dated 8-4-18. It included a supermajority recommendations and minority report option, and potential clarification of DWG membership as outlined in the draft DWG Fact Sheet dated 8-4-18. The discussion indicated dislike for the term "supermajority", for which there were different ideas about the/a definition. There was a substantial desire to maintain a goal of full DWG consensus recommendations. If full consensus cannot me be achieved, when to use a majority recommendations and minority report option should be decided by the DWG on a case-by-case basis, including how great of a majority agreement / consensus is enough to move majority recommendations and a minority report forward. It was noted that DWG members in the minority should be responsible to prepare a minority report, including alternative recommendations to the majority recommendations that the minority opposes. There was also a desire to provide majority recommendations and a minority report together. Al K. suggested that guiding principles be added to the DWG process documents in the Charter to address these concepts. In regard to better defining DWG stakeholder organizations and official members, there was significant opposition, because that could create a need to have equal numbers of members from different stakeholder perspectives, and because some members represent the perspectives of multiple stakeholder organizations. Al will revise the draft charter.
