### RIM Wetlands

After reviewing applications from the November 2024 batching period, a small amount of funds remain. These funds may need to be reserved to cover costs associated with application acreage changes, so if another batching period occurs it will be relatively small. This batching period would occur in February 2025. We anticipate additional funds will be appropriated in July 2025.

### RIM 1W1P

## UPDATED FORMS – PIRF, PIRR, CONSERVATION PLAN WORKBOOK

### PIRF – Practice Implementation Request for Funding

This form replaces the *Practice Implementation/Amendment Request Form*. This form should be used to **request additional funding** for conservation practice implementation. Common scenarios requiring a PIRF would be for enhancement funding, anticipated costs above the maximum conservation plan funding for the practice, and/or practice re-installation. Landowner signatures are no longer required on the PIRF, but they are required on amended Conservation Plans when applicable. PIRF guidance can be found [here](#).

### PIRR – Practice Implementation Reimbursement Request

### Conservation Plan Workbook

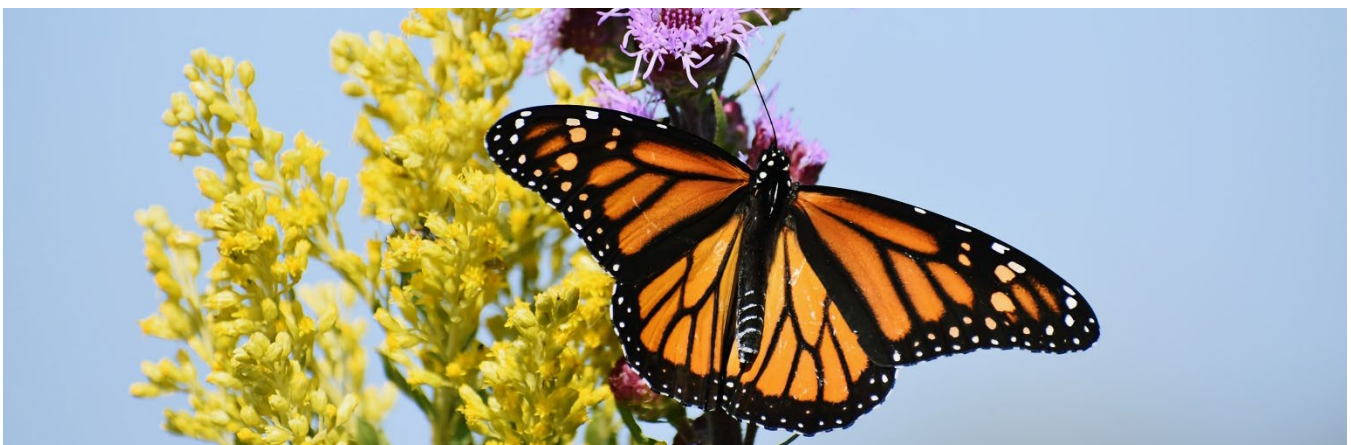

### RIM Handbook

## FOOD PLOT REQUIREMENTS

As noted in the October 2024 RIM Rundown, starting in 2025 BWSR will require landowners who maintain food plots (RR-FP) on their RIM easements to provide proof that the seed planted in food plots is insecticide-free. This includes neonicotinoid seed coatings and foliar applications. Landowners can submit their seed tags to the SWCD after the food plot has been planted. SWCDs will keep record of this within the in-house easement folder. This will be required to be completed annually.

In the coming months, SWCDs will receive an email from BWSR with a county-wide list of all RIM easements that have RR-FP listed in their Conservation Plan. SWCDs can then reach out to the appropriate landowners to notify them of this requirement. A template letter will also be provided for SWCDs to use, if desired.

Please note: if changes have been made to a Conservation Plan without BWSR approval, there may be easements that have food plots but are not in our database. SWCDs should inventory in-house Conservation Plans to identify existing Food Plots that are not found in the provided county-wide list. These updated and signed Conservation Plan Workbooks and Conservation Plan Maps should be sent to BWSR for approval.

This requirement is a result of a request from the Lessard-Sams Outdoor Heritage Council, which funds RIM programs such as CREP, RIM Wetlands, RIM Grasslands, RIM Riparian and Floodplain Restoration, and RIM 1W1P through the Outdoor Heritage Fund.

## RIM PROGRAM SPOTLIGHT

### Easement Enhancement Program

In 2023, BWSR received \$4 million from the General Fund for enhancing existing RIM easements. Enhancements are for the purpose of climate resiliency, adaptation, and carbon sequestration and include but are not limited to increasing biodiversity and mitigating the effects of rainfall and runoff events. These funds will be divided between Wetland and Vegetation Enhancements. This funding is linked to Minnesota's Climate Action Framework. Funding is available until spent or June 30, 2029.

Vegetation Enhancement funds will prioritize projects where the landowner is willing to purchase a custom seed mix, did not receive any portion of the original easement payment, and are willing to provide an elected cost match. All RIM easements are eligible. SWCDs with interested landowners can find guidance and application materials [here](#).

Wetland Enhancement funds are for existing wetland restorations. Enhancements include, but are not limited to, creating more water storage, increasing water quality, and utilizing climate resilient structures. Ideal enhancements include sites that previously had partial restorations but now can increase wetland area, modifications that decrease long-term maintenance costs, and sites that can be modified to reduce downstream flooding.
